Investment Strategy

The Fund invests primarily in domestic and foreign equity securities such as common and preferred stock that are currently paying dividends.

The Fund generally invests in 25 to 50 companies across multiple geographies and market capitalizations but emphasizes developed markets and large capitalization equities.

Under normal circumstances, the Fund will invest at least 40% of its assets in foreign securities, or if the Advisor determines conditions are not favorable, invest at least 30% of its assets in foreign securities.

The Fund primarily invests in US-listed securities including ADRs, foreign securities that trade on foreign exchanges, and ETFs that invest in foreign securities. The Fund may hedge foreign currency exposure.

Investment Process

The primary objectives are to invest in companies that pay a stable and increasing dividend each year and to deliver attractive long-term capital appreciation to investors.

The investment team relies on fundamental, bottom-up analysis to identify companies that they believe have a strong history of rewarding shareholders and have the financial flexibility to continue to increase the dividend.

The investment process identifies businesses with growth characteristics, attractive valuations, and an impressive history of dividend sustainability and cash flow quality.

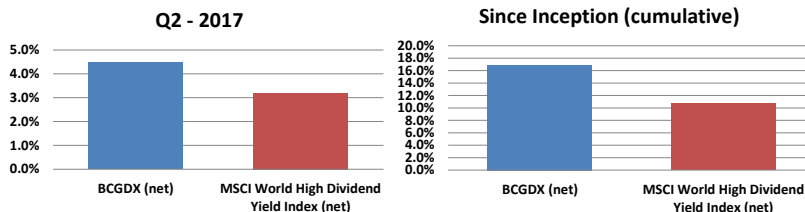

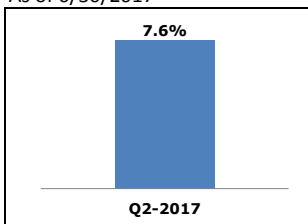
